



**TEMPORARY CLOSURES VARIOUS ROADS
(KEMPLEY PARISH) FOREST OF DEAN DISTRICT**

Gloucestershire County Council, as traffic authority, intends to make an Order, under the relevant provisions of the Road Traffic Regulation Act 1984 (as amended), to temporarily close and restrict part of the roads as detailed in the Schedule below (“the Roads”)

The reason for the closures is for fibre optic broadband installation works.


